Our comprehensive services provide opportunities that help children to develop school readiness skills and assist families in recognizing their role as their child's first and most important teacher. Nutritious meals are served daily. Transportation is provided where possible. Families must meet income eligibility requirements.



#### **Hoosier Uplands After School Program**

Orleans After School Program is a prepaid program serving 80 students. The program operates from afterschool until 5:45 p.m. every day that school is in session. Cost of the program is \$5 per week per student. Springs Valley After School Program is a free program serving 50 students. The program operates from after school until 5:45 p.m. every day that school is in session.

The main purpose of this program is to offer supplemental foods, nutrition education and health care referrals for low-income pregnant, breastfeeding, and non-breastfeeding postpartum women, and to infants and children up to age five who are found to be at nutritional risk. 
